

The red light to stop covid vaccination is on!

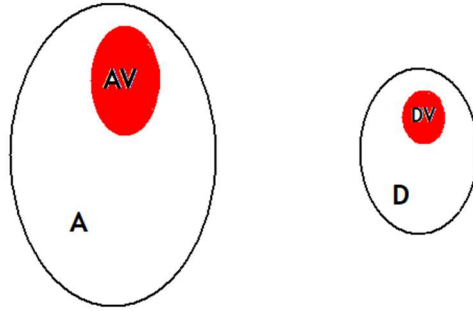

England has one of the most transparent statistics of Covid-19 vaccination. For each period of 4 weeks, the number of dead persons is shown as a sum of dead vaccinated persons and dead unvaccinated persons. These data are allowing detailed mathematical analysis of the Covid-19 vaccine efficacy. By use of set theory, we can build a model which allows the exact extrapolation of how many persons have been saved from death because of Covid-19. The narrative of medical science is that at the beginning of 2020 a world pandemic of Covid-19 has been stated. To save human lives at the end of 2020 the massive vaccination started all over the globe. It is time that we evaluate covid vaccination effectiveness. The official narrative is that with covid vaccination we are saving thousands of lives, on the other side numerous side effects and deaths of vaccination published on EMA, VAERS, and others are not promising.

Mathematical model of Covid-19 vaccines efficacy

Let's see korona vaccination from the perspective of mathematics. We have a set of alive people A in a given country. In this set A , we have a subset of alive people that are vaccinated AV . These people we can call red people. Vaccination has no impact on people's health.

In the period of 4 weeks, people in set A are dying. We have for every 4 weeks a subset of dead people D . As vaccination has no impact on people's health, in a set D we will have the same percentage of vaccinated people as in a set A .



We can write a following equation:

$$\frac{AV}{A} = \frac{DV}{D} \quad (1)$$

$$\frac{\text{alive vaccinated}}{\text{alive}} = \frac{\text{dead vaccinated ideal number}}{\text{dead}} \quad (1).$$

Out of equation (1) follows:

$$\text{dead vaccinated ideal number} = \frac{\text{alive vaccinated} * \text{dead}}{\text{alive}} \quad (2).$$

Using equation (2) we can calculate the number of dead vaccinated persons in England in a given 4 weeks. The number we get is an ideal number where there is no impact of the vaccination on the death rate. When 10% of the population is vaccinated in the group of dead persons 10% will be vaccinated. When 20% of the population is vaccinated in the group of dead persons 20% will be vaccinated and so on. When 100% of the population is vaccinated in the group of dead persons 100% will be vaccinated. This “vaccinated dead ideal number” we can say in terms of physics is “vaccine invariant”.

Now we compare the numbers of dead vaccinated persons in official statistics with the “vaccinated dead ideal number” we calculate. The statistical number of dead vaccinated persons must be lower than the ideal number. In this case, vaccines are saving people’s lives:

$$\text{vaccinated dead} < \text{vaccinated dead ideal number} \quad (3).$$

We can calculate how many persons have been saved from death with vaccination in a given 4 weeks by following equation:

$$\text{saved lives} = \text{vaccinated dead ideal number} - \text{vaccinated dead} \quad (4).$$

In case that the number of vaccinated dead is bigger than the number of calculated dead vaccination has a negative impact on mortality rate, it takes lives, some people have died prematurely because of being vaccinated:

$$\text{lost lives} = \text{vaccinated dead} - \text{vaccinated dead ideal number} \quad (5).$$

The calculation for 32-35 week

Let's calculate the ideal number of dead vaccinated in England between weeks 32 and 35. In England died between 32 and 35 weeks has died 2381 persons. 1756 of them have been vaccinated, see on page 15 [1]. We see that the percentage of vaccinated people in England with one dose in this period is 64.6%, see on page 3 [1]. The population of England was 56.191.000 people in 2021. 64.6% of the entire population is 36.299.300 people.

$$\text{dead vaccinated ideal number} = \frac{36.299.300 * 2381}{56.191.000}$$

$$\text{dead vaccinated ideal number} = 1538.$$

Officially declared vaccinated dead persons between 32 and 35 weeks are 1756.

$$\text{dead declared vaccinated} = 1756.$$

This means that because of the vaccination had prematurely died between 32 and 35 weeks 1756 – 1538 = persons:

$$\text{lost lives} = 1756 - 1538 = 218$$

The calculation for 36-38 week

A “vaccinated” person in this calculation is the person that was vaccinated with the first dose or more. Let's calculate the ideal number of dead vaccinated in England between weeks 36 and 38. In England died between 35 and 38 weeks has died 3165 persons. 2448 of them have been vaccinated, see on page 17 [1]. We see that the percentage of vaccinated people in England with one dose in this period is 65.1%, see on page 3 [2]. The population of England was 56.191.000 people in 2021. 65.1% of the entire population is 36.580.200 people.

$$\text{dead vaccinated ideal number} = \frac{36.580.000 * 3165}{56.191.000}$$

$$\text{dead vaccinated ideal number} = 2060.$$

Officially declared vaccinated dead persons between 35 and 38 weeks are 2448.

$$\text{dead declared vaccinated} 2448.$$

This means that because of the vaccination had prematurely died between 39 and 42 weeks 2448 – 2060 = 388 persons:

$$\text{lost lives} = 2270 - 1832 = 388$$

The calculation for 39-42 week

Let's calculate the ideal number of dead vaccinated in England between weeks 39 and 42. In England died between 39 and 42 weeks has died 2772 persons. 1832 of them have been vaccinated, see on page 17 [3]. We see that the percentage of vaccinated people in England with one dose in this period is 66.1%, see on page [3]. The population of England was 56.191.000 people in 2021. 66.1% of the entire population is 37.142.200 people.

$$\text{dead vaccinated ideal number} = \frac{37.142.200 * 2772}{56.191.000}$$

$$\text{dead vaccinated ideal number} = 1832.$$

Officially declared vaccinated dead persons between 39 and 42 weeks are 2270.

$$\text{dead declared vaccinated} = 1832.$$

This means that because of the vaccination had prematurely died between 39 and 42 weeks $2270 - 1832 = 438$ persons:

$$\text{lost lives} = 2270 - 1832 = 438$$

The calculation for 43-46 week

Let's calculate the ideal number of dead vaccinated in England between weeks 43 and 46. In England died between 43 and 46 weeks has died 3726 persons. 2992 of them have been vaccinated, see on page 31 [4]. We see that the number of vaccinated people in England in this period with the first dose is 67.4%, see on page 3 [4]. The population of England was 56.191.000 people in 2021. 67.4% of the entire population is 36.748.900 people.

$$\text{dead vaccinated ideal number} = \frac{37.872.700 * 3726}{56.191.000}$$

$$\text{dead vaccinated ideal number} = 2511.$$

Officially declared vaccinated dead persons between 43 and 46 weeks are 2992.

$$\text{dead declared vaccinated} = 2992.$$

This means that because of the vaccination had prematurely died between 43 and 46 weeks $2992 - 2511 = 555$ persons:

$$\text{lost lives} = 2992 - 2511 = 481$$

The calculation for 47-50 week

Let's calculate the ideal number of dead vaccinated in England between weeks 47 and 50. In England died between 47 and 50 weeks has died 2956 persons, 2141 of them have been vaccinated, see table 10 on page 38 [5]. By 19 December 2021, the overall vaccine uptake in England for dose 1 was 68.2%, see page 3 [5]. The population of England was 56.191.000 people in 2021. 68.2% of the entire population is 38.322.200 people.

We use equation (2) and we get:

$$\text{dead vaccinated ideal number} = \frac{38.322.200 * 2956}{56.191.000}$$

$$\text{dead vaccinated ideal number} = 2016.$$

Officially declared vaccinated dead persons (one doze or more) between 47 and 50 weeks are 2141.

dead vaccinated declared = 2141

This means that because of the vaccination had prematurely died between 47 and 50 weeks
 $2141 - 2016 = 125$ persons:

lost lives = $2141 - 2016 = 125$

Below we have the results of all time periods:

weeks 32-35:

total dead is 2381, dead vaccinated is 1756, dead because of vaccination is 218 which is 12%

weeks 36-38:

total dead 3165, dead vaccinated is 2448, dead because of vaccination is 388 which is 15%

weeks 39-42:

total dead, 2772, dead vaccinated is 2270, dead because of vaccination is 438 which is 19%

weeks 43-46:

total dead 3726, dead vaccinated is 2992, dead because of vaccination is 481 which is 16%

weeks 47-50:

total dead 2956, dead vaccinated is 2141, dead because of vaccination is 125 which is 6%

If the numbers “dead because of vaccination” would be between 1 and 50 we would have low statistical significance. If only once would happen that vaccination would save the life of only one person, our calculation would have no statistical significance. As we calculate only for five time periods, the results are preliminary but with high statistical significance. It cannot happen that in one of all other time periods, vaccines would save lives. Calculations for all time periods will give us more detailed results but no big surprises will be discovered. The fact is, covid vaccinates are causing premature death not only in England but on the entire planet. Calculations are done by the first two authors (Šorli and Žurej). We will send them to the UK Healthy Security Agency and propose a detailed analysis. They could also do analysis for different age groups as for example:

- under 20
- between 21 and 40
- between 40 and 60
- between 61 and 80
- above 80

Such analysis will put more light on the massive vaccination results. Relation between “dead vaccinated” and “dead non-vaccinated” in a short lifespan of 4 weeks is statistically the most significant result of the Covid-19 vaccinee’s efficacy. Vaccination should significantly decrease the number of dead vaccinated comparing to the number of dead non-vaccinated. We do not have in this case some “hidden variables” that could influence the result. Vaccinated and non-vaccinated people are eating the same food, drinking the same water, breathing the same air,

looking the same TV programs. The mathematics “dead = dead vaccinated + dead non-vaccinated” is indisputable proof that vaccines increase mortality and calls for the immediate stop of covid vaccination worldwide.

Why Prof. Burghardt’s results are ignored by the scientific community?

For the authors of this preliminary report, it is incomprehensible that mainstream science is ignoring the indisputable results of Prof. Burkhardt’s abductions that prove covid vaccinations are the direct cause of autoimmune diseases that many caused death [6]. If in cosmology or physics some significant discovery is communicated to the scientific community, the response is immediate. Because in cosmology and physics we are sworn to the truth, our task is to build the most adequate models of physical reality that are based on observation and scientific data. In the corona crisis, real medical science is put aside, the public opinion is made by the unproved information that covid vaccines are safe and efficient. The safety and efficacy of covid vaccines is a new religion that many medical doctors and scientists are preaching. Because of this new religion, thousands of people are unnecessarily dying.

Results of Dr. Reiner Fuellmich are confirming that the corona crisis is a premeditated crime against humanity [7]. How it is possible that something so terrible is going on at the beginning of 21 century? Western civilization is built on laws that are against the laws of the universe. We are living separately from nature, nature for us is the source of material wealth. Western civilization is becoming so pure in its spirit that it starts eating itself. We are on the path of self-destruction. We are mentally utterly sick, and so we do not have mercy even for our own children. In “old normality” when more than 25 died because of a new vaccine, the vaccination was stopped [8]. In “new abnormality” thousands of people are dying and still, vaccination goes on because we are not civilized, we are a “covid civilization” which means utterly sick, lost in the massive hypnotic that is leading to self-destruction.

Western civilization has lost the sacredness of life

We have lost sacredness; our only God is money. When money becomes the only God, death is not far away. We are destined to die and give space to a new human society that will venerate and respect its real home that is nature. The universe is an eternal non-created system in a permanent dynamic equilibrium [9]. Human society is the subsystem of nature that is the subsystem of planet Earth, that is the subsystem of the Solar system, that is the subsystem of the Milky galaxy, that is the subsystem of our universe. We are part of something much bigger, and we are not aware of it. We are organizing our life on the basis of our restricted understanding of human society, especially the economy. The idea of “profit” is one of the most degenerated ideas of mankind. In nature and in the universe, there is no profit. Energy is freely flowing so that life can appear. An apple is not growing to make a profit; it is grooving to be energy for a man to eat and grow. We subordinated all human activities to making profit. This is our main existential problem.

Red light to stop vaccination is on

Mathematical analysis of Covid-19 vaccines efficacy is a strong scientific proof for immediate stop of covid vaccination. Every day, mainstream media are sending out messages that vaccines are saving human lives and that unvaccinated people are a threat to others. How long this inertia of media lies and intimidation will last is depending on the intelligence of people and the sincerity of scientists and organizations that are in charge of vaccinations. With prolonged vaccination, everyday people are unnecessarily dying. In the past, covid vaccines did not solve anything regarding human health and will not save human health in the future. The red light for the end of vaccination is on. Let's open our eyes and see the Truth. Our results are preliminary but evident enough that by performing a detailed analysis, the UK Health Security Agency will get more detailed results about the fact that massive vaccination has caused more damage than benefit. The idea that Covid-19 vaccination is preventing people from dying because of Covid-19 is false. Yes, people are dying because of Covid-19. But being vaccinated with covid vaccine means you have more chances to die. Vaccinated people are dying at a higher rate than unvaccinated people. This was already confirmed by German scientists [10]. Research of Ingrid Tojersen is confirming that Covid-19 vaccination has been causing deaths of the elder population [11,12]. Our preliminary results are in tune with the clinical results of Prof. Burghardt, the statistical results of Prof. Dr. Rolf Steyer and Dr. Gregor Kappler, and the statistical results of Ingrid Tojersen. We know in science when clinical results are overlapping with statistical results there will be no big surprises. Our results are statistically significant enough to call the international scientific community for immediate stop of Covid-19 vaccination worldwide.

In 2020, we had a worldwide excess of mortality because of the Covid-19 pandemic. In 2021, we started with massive vaccination worldwide. Official statistics data are, in Slovenia have died in the first 11 months of 2021 71 persons more than in the same period of 2020 [13]. How it is possible that despite massive protection against Covid-19 still, we have more dead persons in 2021 than in 2020 when there was no vaccination? It is clear now that the premiss "Covid-19 vaccines are preventing infections and saving lives" is not true. Both, unvaccinated and vaccinated people are equally exposed to Covid-19. Data are confirming that vaccinated people are dying at a higher rate than unvaccinated. A recent article in LANCET is confirming that Covid-19 is spreading with a similar rate between unvaccinated and vaccinated: "This study showed that the impact of vaccination on community transmission of circulating variants of SARS-Cov-2 appeared not to be significantly different from the impact among unvaccinated people" [14]. Research of Sivan Gazid and co-authors is confirming that natural immunity of unvaccinated people is far better protection than covid vaccines [15]. At this point, an immediate stop of covid vaccination would be the best action to protect public health.
